COURSE INFORMATION:

SPC School of Dental Hygiene Competencies: This course will address the following SPC School of Dental Hygiene Competencies:

- 1. Apply ethical reasoning to patient care and comply with state and federal laws governing the practice of dentistry and dental hygiene.
- Use screening, referral and education to bring consumers into the health care delivery system by assessing, planning, implementing and evaluating dental hygiene treatment and community programs.
- 3. Provide comprehensive dental hygiene care by applying basic and advanced principles of dental hygiene
- 5. Assume the roles of the profession (clinician, educator, researcher, public health, corporate, administrator and entrepreneur) as defined by the ADHA and advance the profession through leadership, service activities and affiliation with professional organizations.
- 6. Commit to self-assessment and life-long learning in order to provide quality care.

Course Description: Prerequisites: DEH 1800 with a grade of "C" or better and DEH 1800L with a grade of "C" or better. This course is designed to expand students' knowledge of dental hygiene practice including special needs patients, expanding functions and various adjunctive services. 32 contact hours.

Learning Outcomes and Objectives:

- 1. The student will demonstrate the ability to assess and plan population based activities to prevent disease and promote health in a community based oral health program or programs by:
- a. assessing and identifying a target population and determine its oral health needs.
- b. planning a program to meet the oral health needs of the target population while promoting oral health. c. implementing the program in the target population.
- d. evaluating the program through an established mechanism that demonstrates if the program meets the identified oral needs of the target population.
- 2. The student will demonstrate the ability to implement and evaluate community based oral health programs to various target populations utilizing appropriate educational methods and preventive services by:

- a. utilizing community dental public health principles in the program implementation and evaluation. b. utilizing appropriate communication skills including visual aids to the target population.
- c. utilizing appropriate educational principles to the target population.
- d. assessing the target population's current oral health knowledge and abilities by identifying strengths, weaknesses and plausible alternatives.

3. The student will describe the different teaching methods and learning styles appropriate for various target groups by:

- a. comparing and contrasting the adult learner with the child learner.
- b. utilizing the teaching strategies most effective for the various populations

Prerequisites: Prerequisites or co-requisite: DEH 2701with a grade of "C" or better.

- 4. Students will follow all SPC department and international rules and guidelines and will also follow all Great Shape Inc Rules and Regulations at all times.
- Students will never leave the assigned Jamaican property unescorted or by themselves and will
 only travel about the property and throughout Jamaica with another person from SPC never
 alone.
- 6. Students will complete Jamaica packet and turn into Mrs. Krueger within two weeks upon return.
- 7. Students will put together, as a team, a movie/power point presentation, have it viewed and approved by Mrs. Krueger within two weeks upon return and then present to department, advisory board and any other requests by SPC.
- 8. Students will work together as one team for fundraising and all money raised with be put in one account to be shared by all. Once all expenses are paid remaining funds will be used to purchase additional equipment and supplies to better the SPC international program.
- 9. Students will be required to blog for SPC International department about their experience.

Any deviation from the above will result in disciplinary action and can result in the student being asked to withdrawal from this course.

Participation grade criteria: in order to receive full credit each student must:

- access MyCourses for class information, prior to each session
- commit to professional participation in class, the clinics and meetings both at SPC, local community and in Jamaica.
- complete and participate in all meetings, planning and development of fundraising, collection and packing of supplies, developing and presentation of final project.

JURY DUTY:
