SPC's Veterinary Tech program in Costa Rica offers a dynamic learning experience that blends hands-on instruction with the exploration of Costa Rica's breathtaking natural beauty. Designed to provide aspiring veterinary technicians with practical skills and knowledge, this program includes immersive experiences in real-world veterinary settings.

Students have the opportunity to work directly with animals under the guidance of experienced professionals, honing their skills in animal care and medical procedures. Beyond the classroom, students embark on excursions to explore the diverse ecosystems and stunning landscapes of Costa Rica, including visits to beautiful spots such as lush rainforests, pristine beaches, and vibrant wildlife reserves. These excursions not only enrich the learning experience but also offer a unique opportunity for students to appreciate the interconnectedness between veterinary medicine and the natural world.

STUDY ABROAD APPLICATION REQUIREMENTS

Approval for participation in the program is subject to the participant:

- Being in good academic standing at the time of application (cannot be on academic warning, probation or suspension).
- Being enrolled for credit in an approved Study Abroad program course.
- Interviewing with program's lead faculty member.
- Being approved by the Center for International Programs. Paying all deposits and fees according to the fee schedule.
- Obtaining all immunizations required by the Centers for Disease Control (CDC). In addition, participants are strongly encouraged to get all immunizations and preventative treatments recommended for the particular country and regions through which they will be traveling.

MEETING INFORMATION/ATTENDANCE POLICY:

The policy notes that each instructor is to exercise professional judgment and define "active participation" in class (and therefore "attendance"), and publish that definition in each syllabus. - Understand a variety of health issues and considerations common to domestic and wild animals in Costa Rice.
- Critically reflect on individual growth and transformation by means of structured reflection sessions and transformative assessments
- Demonstrate professional competencies through practical engagement with project partners and the application of intercultural communication skills, attitudes and values in daily interactions

Although it is not required by the CDC, two inoculations are recommended when traveling Costa Rica and it is strongly suggested that all participants acquire them: hepatitis A, Hepatitis B, and Typhoid. Due to the nature of the course, we will be working with wild animals and Rabies vaccinations are required.

The lead faculty member on the program will carry emergency safety supplies appropriate for the environment and first aid care.

In addition, specifics regarding safety in an unfamiliar environment are covered in participant orientation, including the Study Abroad Emergency Checklist. This checklist covers knowing where to go in emergencies (how to get there, transportation options), emergency contact information (home and local) and contact numbers (local 911 equivalent, embassy, police, hospital, etc.), back-up plans, special conditions, emergency kits, and cash reserves and alternatives. Closer to the time of travel, current safety conditions can be obtained from the State Department via the Internet.
